

2024 EXTRACURRICULAR ENROLMENT FORM

Saint Stephen's College students can receive individual or group tuition in voice, speech and drama and across a range of instruments. The Performing Arts department is made up of a team of highly skilled tutors and performers, dedicated to making learning enjoyable and meaningful. Tuition is aimed to suit ability levels across a student's musical journey and can take them from learning new skills to pursuing a future in the performing arts.

TERMS OF THIS CONTRACT

1. Fee Payment

(i) All fees are to be paid directly to your child's tutor. Please refer to the Tutor's invoice for methods and times for payment, and please notify your child's tutor when payment has been made. Lessons may be terminated if payment is not made by the due date.

2. Student and Tutor Absences

- (i) If your child's tutor is absent from any lesson, the lesson will be rescheduled and made up.
- (ii) If your child is unable to attend a lesson due to illness or absence, please contact the tutor directly, not via the school offices. Tutors are available to be contacted via the phone number they have provided (between the hours of 7am to 5pm) or email. A minimum of 24 hours' notice of absence must be given before the scheduled lesson otherwise lesson fees <u>will apply</u>, and the tutor is not obliged to reschedule. Emergency absences may be made up at the discretion of the tutor. Lessons missed due to holidays taken during term time will not be credited nor re-scheduled.

3. Discontinuing lessons

(i) Students are to remain committed to their studies for the full year unless otherwise advised in writing. Written notice of your wish to withdraw from lessons must be received <u>four weeks in advance</u>. Otherwise, you will be charged a total of four weeks from receipt of your notice.

4. Continuing lessons

(i) Enrolments are *automatically transferred* over to the next term/year and it is not necessary to fill out another form.

5. Exam Enrolment and Accompaniment Fees

(i) Students may be enrolled for practical and/or theoretical Music examinations through organisations such as AMEB or Trinity College London by their tutor. Tutors will suggest an accompanist, and fees must be paid directly by parents to the accompanist.
